The undersigned is directed to convey the sanction of competent authority for collection of processing fees for Import & Export applications and enhancement of accommodation charges for keeping the animals at Animal Quarantine & Certification Services stations as per details given **with effect from 01.05.2025**:

- The processing charges for export certifications issued by AQCSs to be fixed at Rs.500/- as token charges.
- The processing charges for import clearance by AQCSs to be fixed at Rs.1,000/- per bill of entry or per application for import of livestock, livestock products, pets etc.
- Accommodation charges during Quarantine:
