- I undertake that both Customs and Animal Quarantine & Certification Service (AQCS) have all right to inspect the above holding facility at any time to ensure that the consignment is held securely in full quantity with proper control and Biosecurity Measures.
- I undertake and bear full responsibility that in case of non issue of final clearance by AQCS, the entire cargo will be moved/transferred back to Customs jurisdiction with full biosecurity measures for further necessary action. I also undertake to comply and carry out all directions regarding destruction/re-export/deportation/any other issue in respect of the above consignment as directed by AQCS and other Competent Authority at my own cost.
- I undertake that the importer will not seek any damages, costs, expenses or other compensations whatsoever from concerned Officer of AQCS and the Department of Animal Husbandry, Dairying & Fisheries that may arise due to refusal of entry of livestock product into India or refusal of re-entry into the country of origin/export.
- I undertake that in case of non compliance of any of the above condition, the importer will not be eligible to avail the above mentioned facility in future. Besides, the importer will also be liable for any appropriate action as deemed necessary by competent authority including AQCS & Customs.
